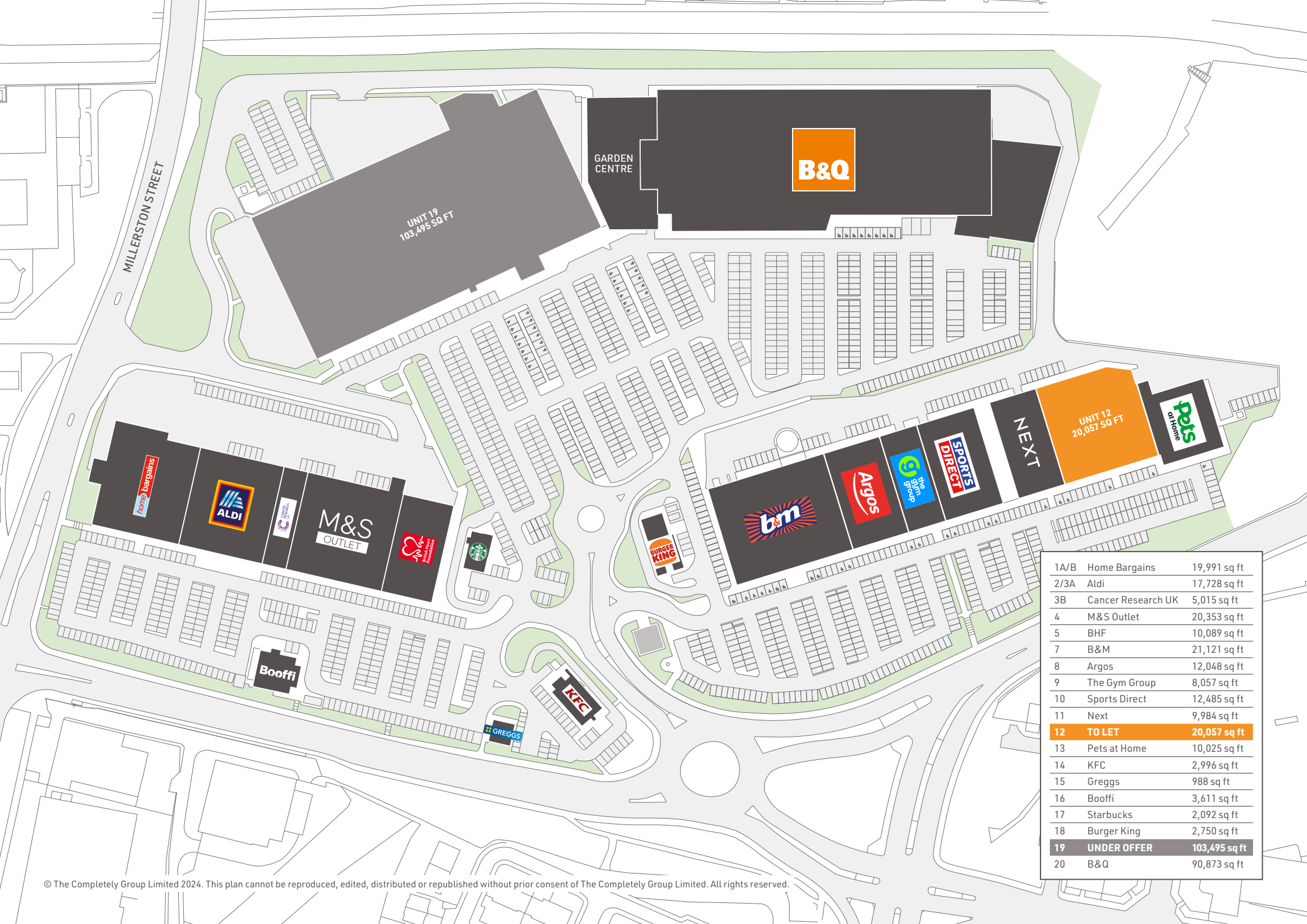

Description

- The Forge Retail Park is Scotland's 4th largest retail park ranked 16th largest in the UK.
- The Forge Retail Park lies adjacent to; The Forge Shopping Centre (circa 450,000 sq ft), Celtic Football Club, the Sir Chris Hoy Velodrome and the Emirates Arena.
